Hutchins moved, Reimink seconded, to approve payment of the bills dated 01/11/2023 as presented from the following funds with the addition of McKenna bill from General Fund for \$1,600.00: General Fund-\$22,445.89; Fire Fund- \$17,203.63; First Responder Fund- \$4,276.49; Road Fund-\$47,086.97. Motion carried.

Committee Reports

Fire Chief, Dan Diaz, reported that new hire Justin Denbow would be starting fire academy. Kevin Stevens will have Ferrara Truck ready by mid-February. The parts truck will continue to be stored outside at Stevens Diesel shop.

Cemetery Sexton, AJ Broe, reported 2 burials. Damage was found at Taylor Cemetery. Tree cutting service hired by Consumers Energy, was found to have done this damage. Clerk Phelps contacted CE and the company hired will be taking care of the damage.

Planning Commission Rep, Dick Hutchins reported that there was no meeting in December. The new Masterplan will be part of the agenda for the January meeting. They have received close to 200 responses to the survey.

Hebert moved, Hutchins seconded, to approve the insurance renewal from Trident presented by HUB for \$31,480.00. Motion carried.

Hebert moved, Phelps seconded, to approve the Outdoor Entertainment Permit for 2023 for Virtue Cider. Motion carried.

Hutchins moved, Reimink seconded, to approve applying for the Allegan County Community Foundation Grant. Motion carried.
