

**GANGES TOWNSHIP BOARD  
REGULAR MONTHLY MEETING  
MINUTES OF DECEMBER 13, 2022**

Supervisor Hebert called the meeting to order at 7:00pm at the Ganges Township Hall located at the corner of 119<sup>th</sup> Ave and 64<sup>th</sup> St. Board members present by roll call attendance: Hutchins, Reimink, Hebert, Phelps and Mohr.

Reimink moved, Mohr seconded, to approve the Agenda of December 13, 2022 as presented. Motion carried.

**Correspondence** – An email was received from Marcia Weston, 2246 Lakeshore Dr, concerning the continued Lake Michigan beach erosion and the equipment that’s been parked for a number of years.

Hutchins moved, Reimink seconded, to approve the regular meeting minutes of November 9, 2022. Motion carried.

Hutchins moved, Reimink seconded, to approve payment of the bills dated December 13, 2022 as presented from the following funds: General Fund- \$34,665.39; Fire Fund- \$6,208.18; First Responder Fund- \$1,402.28; Ambulance Fund-\$3,624.65; Road Fund-\$48,498.61. Motion carried.

**Committee Report**

Dan Diaz, Fire Chief, reported that calls are up from last year.

AJ Broe, Cemeteries and Parks, reported 1 burial for the month. Plummerville Cemetery Arch that was damaged has been stabilized.

Dick Hutchins, Planning Commission representative reported that work continues with McKenna on the new Master Plan. The December meeting has been cancelled.

**Unfinished Business**

Will continue to work on applying for DNR Spark Grant. We missed the first round, but will shoot for the second round.

The parts truck will be moved to Station 1 and eventually sold.

**New Business**

Hebert moved, Reimink seconded to reappoint Phil Badra, Jim Loew, and Judith Jensen to the Board of Review, term ending 12/30/2024. Motion carried.

Hebert, moved, Phelps seconded to accept the notice from Broe's Mowing that his service will be dissolving effective November 28<sup>th</sup>, 2022.
