GANGES TOWNSHIP BOARD PUBLIC HEARING & REGULAR MONTHLY MEETING MINUTES OF JUNE 13, 2023

APPROVED

Supervisor Hebert called the Public Hearing to order at 7:00 P.M. at the Ganges Township Hall located at the corner of 119th Ave. and 64th St. Board members present by roll call attendance: Hutchins, Reimink, Hebert, Phelps, and Mohr.

Public Comments - None

Supervisor Hebert presented the Proposed Property Tax Millage Rates for the 2023/2024 Fiscal Year. Hebert explained the rates to be levied, and asked for questions and comments though none were received.

Hebert then reviewed the proposed 2023/2024 General Fund, Fire Fund, Road Fund, Ambulance Fund, and First Responder Fund budgets with no questions asked by the audience.

Hebert closed the Public Hearing and opened the Regular meeting at 7:05 pm.

County Commissioner Dean Kapenga updated the audience on things happening at the county level.

Reimink moved, Mohr seconded, to accept the agenda dated 6/1/2023. Motion carried.

Correspondence - Email received from Michael O'Connor asking for private security at Campit.

Reimink moved, Hutchins seconded, to approve the regular meeting minutes of 05/16/23 as presented. Motion carried.

Hutchins moved, Mohr seconded, to approve the special meeting minutes of 05/31/23 as presented. Motion carried.

Hebert moved, Mohr seconded, to approve the proposed amendments to the Fiscal Year Budget ending June 30, 2023 as follows: **General Fund-**Increase Township Board \$4,321.00, Increase Treasurer Expenses \$1,137.00, Increase Zoning Administration (MTS) Salary \$149.00, Increase Planning Commission \$4,784.00, Increase Insurance \$947, and Decrease in Contingency \$11,338.00. **Fire Fund-**Increase Operating Supplies \$1,561.00, Increase Contracted Services \$300.00, Increase in Equipment Repair/Maintenance \$3,794.00, and Decrease Building/Land Improvement \$5,655.00. Motion carried.

Mohr moved, Hebert seconded, to approve payment of the bills dated 6/13/23 from the following funds: General Fund - \$49,032.42; Fire Fund - \$11,844.77; First Responder Fund - \$1,147.25; Ambulance Fund - \$3,624.65. Motion carried.

Dan Diaz, Fire Chief, reported that the Ferrara Fire Truck will be done by July meeting. Should have new air packs by July 1.

A J Broe, Cemetery Sexton- Absent. Hebert reported 2 burials for the month of May.

Dick Hutchins, Trustee Planning Commission reported that PC continues to work on the Master Plan.

Mohr moved, Reimink seconded to adopt the proposed General Fund 2023/2024 Fiscal Year Budget dated 6/13/23 as presented with an effective date of July 1, 2023. Motion carried.

Reimink moved, Hebert seconded to adopt the proposed Fire Fund 2023/2024 Fiscal Year Budget dated 6/13/23 as presented with an effective date of July 1, 2023. Motion carried.

Hutchins moved, Reimink seconded to adopt the proposed Road Fund 2023/2024 Fiscal Year Budget dated 6/13/23 as presented with an effective date of July 1, 2023. Motion carried.

Hebert moved, Phelps seconded to adopt the proposed Ambulance Fund 2023/2024 Fiscal Year Budget dated 6/13/23 as presented with an effective date of July 1, 2023. Motion carried.

Reimink moved, Mohr seconded to adopt the proposed First Responders Fund 2023/2024 Fiscal Year Budget dated 6/13/23 as presented with an effective date of July 1, 2023. Motion carried.
