

**GANGES TOWNSHIP BOARD
REGULAR MONTHLY MEETING
MINUTES OF JULY 11, 2023**

Dick Hutchins, Trustee, reported that the June PC meeting was cancelled and that the next meeting would be July 25th. The Public Hearing input for the Master Plan would be held in August.
