The Master Plan (MP) discussion continued with Danielle **Bouchard** from McKenna. **Bouchard** presented the completed survey results and discussed the MP Goals and Objectives that the PC would like to see updated. The township's last master plan vision statement reads: Ganges Township's preferred future is focused on protecting and maintaining its existing rural character and high quality of life in an atmosphere of continued growth. The township's desired future includes preservation of the township's agricultural areas, environmentally sensitive areas and natural features. Protection of agricultural uses, lakes, wetlands, groundwater, and dunes is paramount. Also critical is ensuring that land uses are targeted to areas that have the capacity to accommodate those uses. The survey results show that the majority of the responders agree with the vision statement and want to keep it in the next ten-year master plan.

Topics like adding some definitions, reformatting some of the subpoints, and moving some of the

current goals to the Zoning Plan were also discussed. Commercial vs. Agri-Tourism Uses, alternative energy, funding public access to Lake Michigan and other recreational areas, and creating a shoreline protection overlay district were some of the other subjects deliberated on. It was decided that **Bouchard** will draft the public notice for March's Public Hearing and **Smalley** will post the notice in the newspaper.
